Object: New Delegated Regulation (UE) 2024/3085

Please note that as of 12/29/2024, Delegated Regulation (EU) 2024/3085 amending Reg. (EU) 2019/934 enters into force.

The change introduced by this regulation that has the most impact on our business is the introduction of a maximum use limit for gum Arabic of

- 80 g/hL for red fortified wines
- 30 g/hL for all other wines

as provided for in Sheet **3.3.6. TRAITEMENT A LA GOMME ARABIQUE** of the International Code of Oenological Practices.

As of Dec. 29, therefore, the amount of gum Arabic, expressed as dry matter, that can be used in wines produced within the European Union shall not exceed the above limits.

Because products packaged before the new regulation came into effect may have incorrect dosage statements on the label, below and for each product we indicate the use limits in effect as of December 29.
